# Request for Permission to Install AC/Heat Pump Instructions and Application Form

**Application Form.** Unit owners must submit a completed "Request for Permission to Install AC/Heat Pump" application form to the management company. Applications may be sent by email or U.S. mail using the addresses on the application form. The Board and management company prefer emailed PDF applications, if possible.

The following supporting documents must be included with the application:

- A copy of the AC/heat pump contractor's insurance certificate naming the Village at Riverbend as an additional insured
- A copy of the electrical contractor's insurance certificate naming the Village at Riverbend as an additional insured
- A photo showing the proposed location of the outside compressor and shed enclosure/cover
- Construction sketches for the new shed enclosure/cover or for modifications of the existing shed enclosure, including front and side elevations showing dimensions and clearances
- Town of Ashland building permit (electrical work)
- Written approval from the Ashland Fire Chief for installation of ancillary components in the chimney chase (if applicable)

Upon receipt, the management company will forward the application to the Board for review.

**Notification of Abutting Owners.** Applicants must notify abutting unit owners of the proposed installation and provide them with a photo of the proposed location and construction sketches of the shed enclosure or cover *before* submitting the application to the management company. After the application is submitted, abutting unit owners have the right to comment on, but not to reject, the proposed installation. Comments may be sent to the Board at <a href="mailto:directors@villageatriverbend.net">directors@villageatriverbend.net</a>. Applicants should work with their neighbors to resolve any concerns with the planned installation prior to application submission.

**Application Review.** Upon receipt of the application from the management company, the Board of Directors will review the request and notify the applicant(s) of its decision within 21 days. If approved, unit owners must sign an installation agreement and submit the signed agreement to the management company before the AC/heat pump is installed.

**Right to Reject Application.** If a compressor and enclosure/cover cannot be installed in accordance with the AC/heat pump requirements and guidelines, the Board will work with the unit owner to identify an acceptable alternative, if such alternative exists. The Board of Directors reserves the right to reject any application that the majority of directors deems not in the best interest of the Association in general.
